Going to have higher than normal administrative expenses in the next month or two since we just stopped paying Wild Apricot, still owe COW for last two months, and paid for startup of Star Chapter.

Nathan asked what the \$1,215 charge entitled "Credit Card Charge" entailed. This is due to the ~3% charge paid for taking in payments and is primarily made up of the cost of taking in sponsorship dollars via credit charge.

The "World Workplace" and "World Work Place Expenses" charges consist of sending leadership and one member to World Workplace.

Brett is planning to realign the chapter budget more closely with the corporate budget template.

Motion was approved to pay for the World Workplace scholarship from the scholarship fund.

#### <u>Vice President (Nathan Hansen)</u>

Reported on Facility Fusion. Wisconsin is still recognized as a whole for having a lot of good things going in with IFMA chapters! Offering CEU credits was brought up by Nathan based on discussion at Facility Fusion. Jim Zirbel and Erica Marty have looked into this.
