I am troubled by this because I was a very good boy last year. In any event, with the holidays behind us it is time to focus on our objectives for the first half of 2013. The following are events and areas we will be focusing on in 2013:

- Madison College Certificate Program- Registration has begun for spring classes. There are four classes
 presently offered, descriptions listed below. We are very excited about the educational offerings, and our
 partnership with Madison College. You can go online to check out registrations, credits, cost, and other
 details at http://madisoncollege.edu/program-info/facilities-management
- Project Management Fundamentals- Introductory Project Management class which develops the following project management skills; defining projects; planning projects; scheduling projects; controlling projects; and leading projects. Emphasis will be placed on applying these fundamentals, as both a participant and project leader, in case studies and group projects, using worksheets and Microsoft Project software. Skills covered include but are not limited to Project Charters, Gant Charts, Critical Paths, Milestones, Risk Control and Prioritization, Teamwork and Problem Solving.
- Safety in the Workplace-The learner applies the skills and tools necessary to provide a safe and secure work environment. Each learner will demonstrate the application of strategies regarding safety awareness, compliance, investigation and documentation. Other topics include: safety orientation, chemical safety, right-to-know, inspections, risk analysis, workplace violence, substance abuse, first aid, fire and electrical safety, emergency preparedness and liaison with external agencies.
- Maintenance Management Industrial Maintenance Program- Emphasizes maintenance management
 and quality control techniques to give maintenance students an understanding of their roles in an organization. Covers maintenance record keeping, parts ordering and shop operation.
- Building Management Systems-Studies computer-based energy and building control systems in detail.
 Includes sensing devices, pneumatic and otherwise, as well as basic energy efficiency calculating. Also presents and discusses cost- and energy-saving ideas and plans.
- CFM/FMP classes- sign for FMP classes that will be starting on February 27th and 28th. Go to chapter
 website to get additional information and register for FMP classes. CFM classes have been changed, and
 will be offered in the fall of 2013.
- **Tri-Chapter-** The Madison Chapter will host this year. The event will be held on May 10th, 2013 at American Family's corporate office. We are very excited about this event. The entire program and breakout sessions will be phenomenal. This is definitely one you do not want to miss.

Transportation Demand Management

Transportation Demand Management, or TDM, is an overarching term used to describe strategies that aim to lower the amount of single-occupant vehicle (SOV) trips by encouraging alternative transportation use.

TDM plans generally cover two areas: how to build the infrastructure needed to support alternative transportation use, and the maintenance of programs such as incentives or conveniences. Infrastructure needs include upgrades such as easily accessible bike racks or lockers. There are also a number of programs like a guaranteed ride home taxi voucher system, or educational events that increase the awareness and feasibility.



There are several motives and benefits for developing a TDM plan for your facility.

A TDM plan might even help you avoid a costly expansion to overcrowded parking structures, or may even be required or rewarded by your city. Benefits of a successful TDM plan will be felt both directly and indirectly. Indirectly, your occupants will reap the benefits of alternative transportation use, such as increased exercise, outdoor time, and lower stress from traffic and parking frustrations. An overall raised level of employee happiness and well being has been linked to increased productivity in the workplace. Depending on the size of your facility, a deepened sense of camaraderic could emerge due to the participation in programs and educational events. In terms of direct benefits, cost savings can be realized by a reduced need for parking space or structures. If you have a cost associated with providing parking for your occupants, lowering the amount of SOV's can save money and also time on maintenance. If your facility has regular customers visiting, they may also benefit from increased parking availability and convenience.

Case Study: A busy downtown Madison office building developed a TDM plan in 2006 in order to satisfy a requirement by the city and also to attract prospective renters. They first put into place the needed infrastructure to support alternative transportation use. They also chose to include a car sharing vehicle in their onsite ramp. In addition, they laid out an easy to use and appealing incentive program. This program allowed users to track alternative transportation trips and receive prizes in return. In order to increase awareness and build knowledge of how to use alternative transportation options, they created several informational outlets including a website page, a bulletin board, and a monthly newsletter. The newsletter also lets them highlight an alternative transportation user in an interview. Periodically they host events talking about options and teaching skills needed to successfully use alternative transportation. When they began, their SOV rate was at 65% and it is now at 54%.

An easy addition and start towards a sustainable workplace, a transportation demand management strategy can be beneficial to your facility, your tenants, and your community.


