Mr. Jaeckels has over 20 years of professional and project management experience in air permitting, regulatory compliance and analysis, and emission characterization and modeling. Jeff holds a B.S. in Chemical Engineering from the University of Wisconsin - Madison and is pursuing a Master's Degree in Environmental Chemistry and Technology researching fine particulate formation and impacts. He is a member of the Air and Waste Management Association and the Federation of Environmental Technologists.

September Tour JT Packard, 5:30 p.m. September 28, 2006

JT Packard is the nation's largest independent service provider for all brands of network-critical power equipment: uninterruptible power supply (UPS) systems, batteries, DC plants, generators, and HVAC. During the past year, JT Packard's continued growth has caused an increased need for additional personnel. This increase in personnel stressed the existing 10,000 sq. feet of dedicated office space. As a means to expand office space, but maintain overall building space flexibility, JT Packard elected to install a demountable office solution. This office was installed in existing warehouse area and was configured for an additional 24 employees (2,200 sq. foot). The use of demountable office space provided flexibility in space reconfiguration for future business changes. The tour will include the Operations area, the National Training Center, the above mezzanine build out and the parts stocking warehouse.

After the tour there will be a social get together at Avanti's, a locally owned Verona establishment that just completed a renovation and has a very unique antique bar area.
